ORDINANCE 2002-05

AN ORDINANCE OF THE TOWN OF CAREFREE, MARICOPA COUNTY, ARIZONA, AMENDING SECTIONS 7-2-1 B AND C TO ADD NEW LANGUAGE CONCERNING 7-2-1 B REDUCING THE SPEED LIMIT ON CAVE CREEK ROAD FROM SCOPA TRAIL TO TRANQUIL TRAIL TO TWENTY-FIVE MILES PER HOUR AND TO ADD NEW LANGUAGE CONCERNING 7-2-1 C REDUCING THE SPEED LIMIT ON TOM DARLINGTON DRIVE FROM CAVE CREEK ROAD TO BLOODY BASIN TO TWENTY-FIVE MILES PER HOUR, DECLARING AN EMERGENCY, AND DIRECTING THE TOWN CLERK TO INCORPORATE THE AMENDMENT INTO THE TOWN CODE OF THE TOWN OF CAREFREE, AZ.

BE IT ORDAINED BY THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CAREFREE, MARICOPA COUNTY, ARIZONA AS FOLLOWS:

Section 1. Chapter 7 of the Town Code is hereby amended to substitute subsections B and C as follows:

Section 7-2-1 Speed Limits

- B. On Cave Creek Road from Scopa Trail to Tranquil Trail the maximum speed limit shall be twenty-five miles per hour and from Tranquil Trail to Pima Road, except at stop intersections and as posted, the maximum speed limit shall be thirty-five miles per hour.
- C. On Tom Darlington Drive from Cave Creek Road to Bloody Basin the maximum speed limit shall be twenty-five miles per hour and on Tom Darlington from Bloody Basin to its southern end, except as posted, the maximum speed shall be thirty-five miles per hour.

<u>Section 2.</u> The immediate approval of this Ordinance is necessary for the preservation of the public health and welfare; an emergency is hereby declared to exist; this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor and the Common Council of the Town as required by law. <u>Section 3.</u> The Town Clerk of the Town of Carefree is hereby directed to incorporate this amendment into the Town Code of the Town of Carefree, Arizona. All other provisions of 7-2-1 remain in effect.
